- CRA requirements for audited statements. CCHA would like to change the bylaw to have audited statements as required by CRA. Would like to change by-laws to read from:

At every annual meeting, in addition to any other business that may be transacted, the report of the board, the financial statements and the report of auditors shall be presented and auditors appointed for the ensuing year. The members of a soliciting corporation may, with gross annual revenues less than \$50,000 or any other such sum permitted under the NFP Act and Regulations, by unanimous vote, resolve to not appoint a public accountant.

To:

At every annual meeting, in addition to any other business that may be transacted, the report of the board and the financial statements shall be presented and accountants appointed for the ensuing year.

(The members of a soliciting corporation may, with gross annual revenues less than \$500,000 or any other such sum permitted under the CRA Regulations, by majority vote, resolve to not appoint an auditor.)

10. New Business

- Paula Moore and Aubyn would like to know how the board operates for listening to and accepting new ideas. They would like to propose the CCHA consider the Living Well self-management program. They would like to adapt the program for CHD. Paula is currently a leader for the accredited program and has been told she can adapt the program for CHD. This program is funded by government
- They may be able to meld this program with a CCHA peer support program
- Paula and Aubyn were asked to put a proposal together and submit to the board for review
- The board would like to start committees where work will be done and board will become more of an advisory board
- Committees should be formed based on the Strategic plan
- Board is to review their structure at first meeting in January 2015
